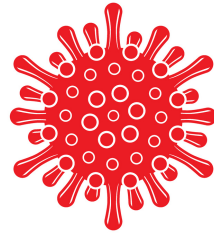


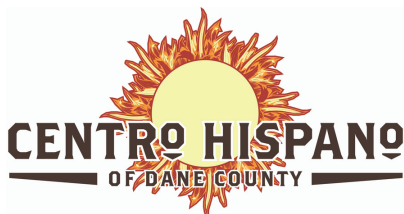

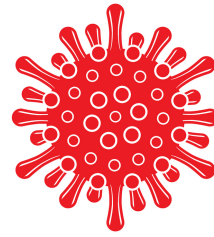

LATINX CONSORTIUM FOR ACTION

The Latinx Consortium for Action (LCA) is a coalition of leaders representing different Latinx-led organizations, professional associations and educational groups in Dane County. The group has been existence since 2016 and represents a space for collective strategy building and action on behalf of the Latinx community.

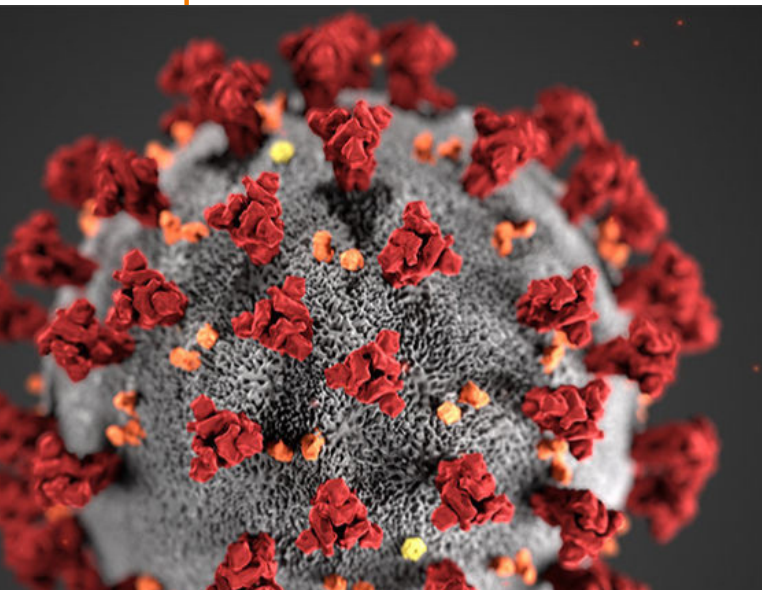
LCA EMERGENCY RELIEF FUND

The LCA Relief Fund was formed at the onset of the COVID-19 pandemic.

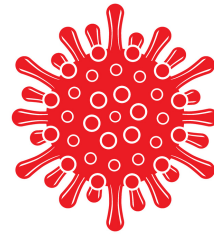
In total, \$1,184,014.56 was distributed in aid to individuals and families. Funds were raised from donor contributions, local foundations, and United Way dollars, as well as \$465,484.82 in CARES Relief Funding through Dane County. A total of 2112 applications were received for aid within 2 weeks of making the fund accessible.

Community members completed an online screener application (individually or with support from LCA organizations) asking for some basic information regarding loss of wages, financial impact, and other sources of support. Funds targeted the undocumented community.

Once screened, applicants received a call back from staff associated with any of the following 5 organizations (Centro, Latino Chamber of Commerce, Unidos, Latino Academy of Workforce Development, Sunshine Place, or the Latino Children and Families Council). The staff did an intake and assessment of needs, as well as provided additional resources during a time of crisis.



THE CRISIS BY THE NUMBERS

Latinx make up about **7%** of Wisconsin's population, but **11%** of the state's confirmed COVID cases and **12%** of hospitalizations. Nationally, data from the Centers for Disease Control and Prevention indicate that Latinx are **2.8** times more likely to be infected and **4.6** times more likely to be hospitalized when compared to white non-Hispanic Americans.

Latinx are **less** likely to have jobs that can be done remotely and **more** likely to work in the industries dubbed "essential" during the pandemic.

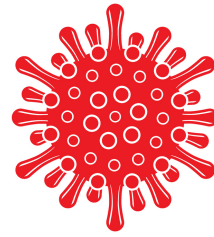
Latinx are also **more** likely to live in multigenerational or crowded homes, increasing potential exposure and making it hard for those who get sick to isolate.

Latinx households earn **46%** less than non-Hispanic white households.

**To be eligible for relief funds
applicants needed to meet the
following criteria:**

For Individuals:

- A resident of Dane County
- Undocumented (An individual who does not have access to a work permit)
- Ineligible for federal stimulus package or EA grant funding
- Have lost income due to COVID-19
- Can demonstrate an emerging need: rent, childcare, food, etc.

For Businesses:

- A business located in Dane County
- Have lost income due to COVID-19
- EIN & ITIN # verification
- Undocumented owner does not have access to federal or state loans
- Can demonstrate an emerging need: property rent, payroll, etc.
- Must be able to submit a P&L statement or verification 2018/2019 Taxes
- Business name or entity ID searchable on DFI website

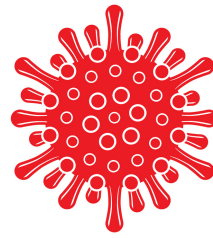

"I'm a father of four and I lost my job 2 weeks ago because of this dreaded virus and since it was a small business there was nothing my boss could do. I am so thankful for this support."

"I work in roofing and because of COVID people don't want for us to go to their homes and because of this I don't have an income to be able to face all the different expenses and barriers my family faces. I am most worried about paying rent. I need the help, thank you for doing this."

"Because right now, I am without work and I am a single mother and have 4 children and we have expenses - like paying rent, the electricity bill, phone, car expenses. That is why it is so urgent for me to please receive some kind of support. I am scared."

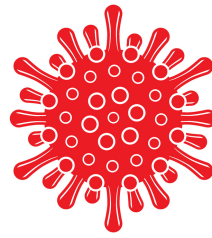

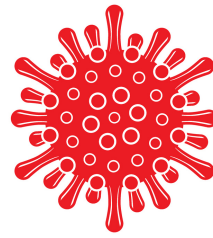
